RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 005, SERIES OF 2025 OF THE MUNICIPALITY OF MANAPLA, NEGROS OCCIDENTAL, COVERING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 4 OF THE SAID MUNICIPALITY IN THE AMOUNT OF FIVE MILLION SIX HUNDRED EIGHTY EIGHT THOUSAND ONE HUNDRED NINETY PESOS AND THIRTY FIVE CENTAVOS (P5,688,190.35)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2025 General Fund Supplemental Budget No. 4 of the Municipality of Manapla, Negros Occidental with an appropriation of P5,688,190.35, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 005, series of 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 005, series of 2025 of the Municipality of Manapla covering the 2025 General Fund Supplemental Budget No. 4 of the said municipality with an appropriation of P5,688,190.35 and considered operative in its entirety effective December 19, 2025, subject to the posting requirement under Section 59 of LGC 1991 and subject further to the conditions:

1. the grant of Service Recognition Incentives (SRI) to government employees for FY 2025 must be in accordance with the provisions of Budget Circular No. 2025-3 dated December 15, 2025 of the DBM;
2. That the grant of 2023 Performance Based Bonus (PBB) shall strictly be in accordance with the provisions of Resolution No. 2024-2 of the Executive Order No. 61, series of 2024 Technical Working Group dated November 27, 2024, JMC No. 2025-001 dated April 30, 2025 and 2025-002 dated June 27, 2025 of the DILG and DBM, and Regional Memorandum of DILG – Negros Island Region dated October 28, 2025;
3. the grant of Productivity Enhancement Incentive (PEI) must be in accordance with the provisions of DBM Budget Circular No. 2025-13, dated December 17, 2025.
4. that Section 56 in relation to Section 326 of the LGC provides that within three (3) days after the approval of the ordinance authorizing annual/supplemental appropriation, the Secretary to the Sanggunian shall forward the said ordinance to the appropriate reviewing authority;

RESOLVED FURTHER, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law and that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
