RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE PROJECT PROPOSAL RELATIVE TO THE FINANCIAL ASSISTANCE THAT WILL BE EXTENDED BY THE PROVINCE TO THE NEGROS OCCIDENTAL REGIONAL FOOTBALL ASSOCIATION (NORFA) FOR THE PARTICIPATION OF FIVE (5) YOUNG FOOTBALLERS FROM NORFA IN THE PHILIPPINE FOOTBALL FEDERATION (PFF) U17 NATIONAL TEAM TRAINING POOL IN METRO MANILA STARTING MARCH 2, 2026 IN THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P100,000.00) TO BE TAKEN FROM THE LUMP SUM APPROPRIATION FOR 2026 (PAGCOR FUND)
