RESOLUTION DECLARING CITY ORDINANCE NO. 2026-003 OF THE CITY OF SIPALAY, NEGROS OCCIDENTAL, AUTHORIZING THE PROPOSED BORROWING OF THE CITY GOVERNMENT OF SIPALAY, NEGROS OCCIDENTAL IN THE AMOUNT OF FOUR HUNDRED SEVENTY EIGHT MILLION FIFTY THOUSAND PESOS (P478,050,000.00) WITH LAND BANK OF THE PHILIPPINES TO FINANCE THE VARIOUS PRIORITY PROJECTS AS A VALID ENACTED ORDINANCE

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

WHEREAS, City Ordinance No. 2026-003 of the City of Sipalay, Negros Occidental, entitled: "***AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE CITY GOVERNMENT OF SIPALAY, NEGROS OCCIDENTAL IN THE AMOUNT OF FOUR HUNDRED SEVENTY EIGHT MILLION FIFTY THOUSAND PESOS (P478,050,000.00) WITH LAND BANK OF THE PHILIPPINES TO FINANCE THE VARIOUS PRIORITY PROJECTS***" was submitted for review by the City of Sipalay to the Sangguniang Panlalawigan of Negros Occidental, to wit:

- A. P125,000,000.00 Term Loan 12 to finance the acquisition of the following lands:
 - a. P71,000,000.00 for 20 hectares New Public Cemetery located at Barangay Gil Montilla, Sipalay City, Negros Occidental;

- b. P9,000,000.00 for 1.5 hectares for New Barangay Site, Brgy. Maricalum, Sipalay City, Negros Occidental; and
 - c. P45,000,000.00 for 3 hectares for New Public Market at Brgy. Gil Montilla, Sipalay City, Negros Occidental.
- B. P120,050,000.00 Term Loan 13 to finance the acquisition of various brand new following equipment:
- a. P62,050,000.00 for the acquisition of various brand new equipment
 - i. Two (2) Units Garbage Compactor;
 - ii. One (1) Unit Suction Truck (6 Cubic);
 - iii. One (1) Unit Suction Truck (8 Cubic);
 - iv. Three (3) Units Dropside Truck;
 - v. One (1) Unit Wheeled Excavator;
 - vi. One (1) Unit Customized Rescue Truck.
 - b. P8,000,000.00 for the acquisition and installation of 100 KW Solar Panel for the New Government Center;
 - c. P42,000,000.00 for the acquisition and installation of Close-Circuit Television (CCTV); and
 - d. P8,000,000.00 for the acquisition and installation of a brand-new elevator unit (8-passenger capacity)
- C. P233,000,000.00 Term Loan 14 to finance the construction of the following projects:
- a. P180,000,000.00 for Site Development of 12 hectares relocation site in Sitio Bunga-bunga, Brgy. Canturay, Sipalay City, Negros Occidental;
 - b. P8,000,000.00 for the construction of a Water Filtration Facility at the New Government Center; and
 - c. P45,000,000.00 for the construction of Water Supply System (Level II) in six (6) barangays (Camindangan, Manlucahoc, Cabadiangan, Nabulao, Maricalum, and Cayhagan)

WHEREAS, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Panlungsod of Sipalay to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

WHEREAS, the said ordinance is in accord with the procedural requirements of the Local Government Code of 1991 and appears to comply with the statutory and regulatory framework governing local government borrowing, particularly Section 297 of Republic Act No. 7160;

WHEREAS, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same,

NOW, THEREFORE, on motion of Hon. Genaro G. Alvarez, IV and unanimously seconded by all the members present,


