**RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2025-005 OF THE MUNICIPALITY OF PONTEVEDRA AUTHORIZING THE PROPOSED BORROWING THE MUNICIPALITY IN THE AMOUNT OF P47,400,000.00 WITH THE LAND BANK OF THE PHILIPPINES TO FINANCE ACQUISITION OF VARIOUS BRAND NEW LOCALLY SOURCED HEAVY EQUIPMENT**

*WHEREAS*, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Municipal Ordinance No. 2025-005 of the Municipality of Pontevedra authorizing the proposed borrowing the municipality in the amount of P47,400,000.00 with the Land Bank of the Philippines to finance acquisition of various brand new locally sourced heavy equipment;

*WHEREAS*, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

*WHEREAS*, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Bayan of Pontevedra to enact pursuant to the provisions of Section 16 (General Welfare Clause) and Section 297 of RA 7160, otherwise known as the 1991 Local Government Code;

*WHEREAS*, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

*NOW, THEREFORE*, on motion of Hon. Patricia Paula M. Alonso-Valderrama, unanimously seconded by all the members present,
