RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2026-03 OF THE MUNICIPALITY OF BINALBAGAN EXTENDING THE DEADLINE IN THE PAYMENT OF BUSINESS TAXES, FEES AND CHARGES AND RENEWAL OF BUSINESS PERMITS AND LICENSES WITHOUT PENALTIES AND SURCHARGES FROM FEBRUARY 2, 2026 TO FEBRUARY 13, 2026

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Municipal Ordinance No. 2026-03 of the Municipality of Binalbagan extending the deadline in the payment of business taxes, fees and charges and renewal of business permits and licenses without penalties and surcharges from February 2, 2026 to February 13, 2026;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Bayan of Binalbagan to enact pursuant to the provisions of Section 16 (General Welfare Clause) and Section 447(a)(1) of RA 7160, otherwise known as the 1991 Local Government Code;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;
