RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2026-03 OF THE MUNICIPALITY OF CALATRAVA, NEGROS OCCIDENTAL, CREATING THE POSITIONS OF TWO (2) FARM WORKER I, SALARY GRADE 2 AND SENIOR AGRICULTURIST, SALARY GRADE 18 IN THE OFFICE OF THE MUNICIPAL AGRICULTURIST'S OFFICE, SUBJECT TO COMPLIANCE WITH SECTION 325 OF THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Municipal Ordinance No. 2026-03 of the Municipality of Calatrava, Negros Occidental, creating the positions of two (2) Farm Worker I, Salary Grade 2 and Senior Agriculturist, Salary Grade 18 in the Office of the Municipal Agriculturist's Office;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject resolution reveals that the same is in accord with the provisions as stated in Section 447(a)(1)(viii) and Section 16, under Republic Act 7160, otherwise known as the Local Government Code of 1991;
