RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2026-05 OF THE MUNICIPALITY OF CALATRAVA, NEGROS OCCIDENTAL, CREATING THE POSITIONS OF ADMINISTRATIVE AIDE III (UTILITY WORKER II), SALARY GRADE 3, IN THE MUNICIPAL HEALTH OFFICE, SUBJECT TO COMPLIANCE WITH SECTION 325 OF THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, thereby presented to the Board for review and appropriate action is Municipal Ordinance No. 2026-05 of the Municipality of Calatrava, Negros Occidental, creating the positions of Administrative Aide III (Utility Worker II), Salary Grade 3, in the Municipal Health Office;
