**RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2026-06 OF THE MUNICIPALITY OF CALATRAVA, NEGROS OCCIDENTAL, CREATING THE POSITIONS OF ADMINISTRATIVE AIDE III (MASON 1), SALARY GRADE 3, ARCHITECT II, SALARY GRADE 16, ENGINEER II, SALARY GRADE 16 AND ADMINISTRATIVE AIDE IV (DRIVER II), SALARY GRADE 4 IN THE MUNICIPAL ENGINEER'S OFFICE, SUBJECT TO COMPLIANCE WITH SECTION 325 OF THE LOCAL GOVERNMENT CODE OF 1991**

**WHEREAS**, thereby presented to the Board for review and appropriate action is Municipal Ordinance No. 2026-06 of the Municipality of Calatrava, Negros Occidental, creating the positions of Administrative Aide III (Mason 1), Salary Grade 3, Architect II, Salary Grade 16, Engineer II, Salary Grade 16 and Administrative Aide IV (Driver II), Salary Grade 4 in the Municipal Engineer's Office;

**WHEREAS**, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

**WHEREAS**, a review of the subject resolution reveals that the same is in accord with the provisions as stated in Sections 447(a)(1)(viii) and 16 under Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, in view of the foregoing, the SP Committee on Human Resource recommends approval of the same;
