RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2026-08 OF THE MUNICIPALITY OF CALATRAVA CREATING THE POSITIONS OF NURSE 1, SALARY GRADE 15 AND ADMINISTRATIVE AIDE 1 (UTILITY WORKER 1) SALARY GRADE 1 IN THE OFFICE OF THE CHIEF OF HOSPITAL, SUBJECT TO COMPLIANCE WITH PS CEILING SET UNDER SECTION 325 OF THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Municipal Ordinance No. 2026-08 of the Municipality of Calatrava creating the positions of Nurse 1, Salary Grade 15 and Administrative Aide 1 (Utility Worker 1) Salary Grade 1 in the Office of the Chief of Hospital;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Bayan of Calatrava to enact pursuant to the provisions of Section 447(a)(1)(viii) and Section 16 (General Welfare Clause) of R.A. 7160 otherwise known as the 1991 Local Government Code, subject to compliance with PS ceiling set under Section 325 thereof;

WHEREAS, in view of the foregoing, the SP Committee on Human Resource recommends approval of the same;
