RESOLUTION APPROVING CITY ORDINANCE NO. 2026-001 OF THE CITY OF SIPALAY, AMENDING THE STAFFING PATTERN OF THE CITY GOVERNMENT OF SIPALAY, NEGROS OCCIDENTAL BY CREATING THE POSITION OF ADMINISTRATIVE ASSISTANT III (COMPUTER OPERATOR I) IN THE CITY AGRICULTURE OFFICE, PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES, SUBJECT TO COMPLIANCE WITH SECTION 325 OF THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is City Ordinance No. 2026-001 of the City of Sipalay, entitled: “AN ORDINANCE AMENDING THE STAFFING PATTERN OF THE CITY GOVERNMENT OF SIPALAY, NEGROS OCCIDENTAL BY CREATING THE POSITION OF ADMINISTRATIVE ASSISTANT III (COMPUTER OPERATOR I) IN THE CITY AGRICULTURE OFFICE, PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES”;

WHEREAS, the creation of plantilla positions is within the corporate and administrative powers of the city government, provided that funding and Civil Service rules are observed;
