RESOLUTION APPROVING CITY ORDINANCE NO. 2026-02 OF THE CITY OF SIPALAY INSTITUTIONALIZING TECHNICAL-VOCATIONAL EDUCATION AND TRAINING (TVET) IN THE CITY OF SIPALAY, PROVIDING FOR ITS STRUCTURE, MANAGEMENT, FUNDING AND FOR OTHER PURPOSES

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is City Ordinance No. 2026-02 of the City of Sipalay institutionalizing Technical-Vocational Education and Training (TVET) in the City of Sipalay, providing for its structure, management, funding and for other purposes;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Panlungsod of Sipalay to enact pursuant to the provisions of Section 16 (General Welfare Clause) of R.A. 7160, otherwise known as the 1991 Local Government Code and at the same time aligns with R.A. 7796;

WHEREAS, in view of the foregoing, the SP Committee on Education recommends approval of the same;
