RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2026-11 OF THE MUNICIPALITY OF CALATRAVA CREATING THE MDRRM OFFICE OF THE MUNICIPALITY OF CALATRAVA THEREBY REPEALING THE SANGGUNIANG BAYAN RESOLUTION NO. 2014-252

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Municipal Ordinance No. 2026-11 of the Municipality of Calatrava creating the MDRRM Office of the Municipality of Calatrava thereby repealing the Sangguniang Bayan Resolution No. 2014-252;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Bayan of Calatrava to enact pursuant to the provisions of Section 16 (General Welfare Clause) and Section 447(a)(1)(viii) of R.A. 7160, otherwise known as the 1991 Local Government Code;

WHEREAS, in view of the foregoing, the SP Committee on Disaster Preparedness recommends approval of the same;
