***RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2025-007 OF THE MUNICIPALITY OF HINOBA-AN, NEGROS OCCIDENTAL, PROVIDING FOR AN ANNUAL MANDATORY TRAINING PROGRAM FOR BARANGAY OFFICIALS, FUNCTIONARIES, PUROK LEADERS AND ACCREDITED LOCAL ORGANIZATIONS ON DISASTER RISK REDUCTION, EMERGENCY RESPONSE AND OTHER RELATED CAPACITY-BUILDING ACTIVITIES, AND FOR OTHER PURPOSES***

***WHEREAS***, thereby presented to the Board for review and appropriate action is Municipal Ordinance No. 2025-007 of the Municipality of Hinoba-an, Negros Occidental, providing for an annual mandatory training program for barangay officials, functionaries, purok leaders and accredited local organizations on disaster risk reduction, emergency response and other related capacity-building activities, and for other purposes;

***WHEREAS***, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

***WHEREAS***, a review of the subject resolution reveals that the same is in accord with the provision as stated in Section 447(a)(1) under Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

***WHEREAS***, in view of the foregoing, the SP Committee on Disaster Preparedness recommends approval of the same;
