RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2025-09 OF THE MUNICIPALITY OF CALATRAVA, NEGROS OCCIDENTAL MANDATING THE ESTABLISHMENT OF BARANGAY EMPLOYMENT SERVICE OFFICES (BESO) IN ALL BARANGAYS OF THE MUNICIPALITY OF CALATRAVA AND FOR OTHER PURPOSES

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

WHEREAS, Municipal Ordinance No. 2025-09 of the Municipality of Caltrava mandating the establishment of Barangay Employment Service Offices (BESO) in all barangays of the Municipality of Calatrava and for other purposes was submitted for review by the Municipality of Calatrava to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, the subject ordinance seek to enhance the administrative capability of the local government unit by filling essential manpower gaps;
