RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2025-10 OF THE MUNICIPALITY OF CALATRAVA, NEGROS OCCIDENTAL, MANDATING THE ESTABLISHMENT OF AN OVERSEAS FILIPINO WORKERS (OFW) HELP DESK IN EVERY BARANGAY OF THE MUNICIPALITY OF CALATRAVA AND PROVIDING GUIDELINES FOR ITS IMPLEMENTATION

WHEREAS, thereby presented to the Board for review and appropriate action is Municipal Ordinance No. 2025-10 of the Municipality of Calatrava, Negros Occidental, mandating the establishment of an Overseas Filipino Workers (OFW) Help Desk in every barangay of the Municipality of Calatrava and providing guidelines for its implementation;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject resolution reveals that the same is in accord with the provision as stated in Section 16 under Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, in view of the foregoing, the SP Committee on Labor recommends approval of the same;
