WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 2026-570 of the City of Victorias approving the various resolutions of the City Development Council dated February 11, 2026 (CDC Resolution Nos. 01-02-2026, 02-02-2026 and -3-02-2026);
