***RESOLUTION APPROVING ORDINANCE NO. 2025-025 OF THE CITY OF VICTORIAS, NEGROS OCCIDENTAL, AMENDING SECTIONS 11 TO 13 OF ORDINANCE NO. 2022-26 ALSO KNOWN AS THE REVISED MARKET CODE OF VICTORIAS CITY***
