
RESOLUTION APPROVING ORDINANCE NO. 26-03 OF THE CITY OF SAN CARLOS ENACTING THE SAN CARLOS CITY CODE FOR RESPONSIBLE PET OWNERSHIP, PRESCRIBING REGULATORY FEES AND PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Ordinance No. 26-03 of the City of San Carlos enacting the San Carlos City Code for Responsible Pet Ownership, prescribing regulatory fees and penalties for violation thereof and for other purposes;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Panlungsod of San Carlos to enact pursuant to the provisions of Section 16 (General Welfare Clause), Section 458, Section 129 and Section 153 of R.A. 7160, otherwise known as the 1991 Local Government Code and at the same time consistent with national policies embodied in RA No. 9482 (Anti-Rabies Act of 2007 and RA No. 8485, as amended by RA No. 10631 (Animal Welfare Act));

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;


