RESOLUTION DECLARING ORDINANCE NO. 780, SERIES OF 2026 OF THE CITY OF TALISAY, NEGROS OCCIDENTAL, PRESCRIBING THE GUIDELINES FOR ADJUDICATION OF STALLS, PRESCRIBING THE MARKET AND SLAUGHTERHOUSE FEES, AND RULES AND REGULATIONS FOR THE OPERATION OF THE CITY PUBLIC MARKET AND SATELLITE MARKETS IN THE BARANGAYS WITHIN THE CITY OF TALISAY, NEGROS OCCIDENTAL, PROVIDING PENALTIES FOR VIOLATION THEREOF" AS A VALID ENACTED ORDINANCE

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

WHEREAS, Ordinance No. 780, Series of 2026 of the City of Talisay, Negros Occidental, entitled: "AN ORDINANCE PRESCRIBING THE GUIDELINES FOR ADJUDICATION OF STALLS, PRESCRIBING THE MARKET AND SLAUGHTERHOUSE FEES, AND RULES AND REGULATIONS FOR THE OPERATION OF THE CITY PUBLIC MARKET AND SATELLITE MARKETS IN THE BARANGAYS WITHIN THE CITY OF TALISAY, NEGROS OCCIDENTAL, PROVIDING PENALTIES FOR VIOLATION THEREOF" was submitted for review by the City of Talisay to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Panlungsod of Talisay to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

WHEREAS, Republic Act No. 7160, otherwise known as "The Local Government Code of 1991," states under section 16 thereof that:

"Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. xxx."

WHEREAS, Section 458 of the same Code authorizes the Sangguniang Panlungsod to enact ordinances intended to regulate economic activities within the city and to ensure the efficient delivery of basic services and facilities and included within such authority is the power to regulate public markets and slaughterhouses, to prescribe reasonable fees and charges for the use of public facilities, and to establish rules and regulations necessary for their proper operation and management;

WHEREAS, Ordinance No. 780, Series of 2026 of the City of Talisay seeks to prescribe the guidelines for the adjudication of market stalls, establish market and slaughterhouse fees, and provide rules and regulations governing the operation of the city public market and satellite markets within the barangays of the city. These measures are within the legislative competence of the Sangguniang Panlungsod as part of its authority to regulate local economic enterprises and to maintain public markets as essential public facilities serving the community;

WHEREAS, the imposition of reasonable fees and the establishment of regulatory guidelines for the operation of public markets and slaughterhouses are recognized exercises of the city's police power and fiscal authority under the Local Government Code and such regulations are intended to ensure order, sanitation, efficient administration, and the equitable use of market facilities for the benefit of the public;

WHEREAS, said ordinance has complied with the posting requirements as required under the Local Government Code;

WHEREAS, the ordinance complies with the six (6) generally accepted principles for a valid ordinance, as adopted by the Sangguniang Panlalawigan of Negros Occidental, which are:

*It must not contravene the Constitution or any statute.
It must not be unfair or oppressive.
It must not be partial or discriminatory.
It must not prohibit but may regulate trade.
It must be general and consistent with public policy.
It must not be unreasonable.*

WHEREAS, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;


