**RESOLUTION DECLARING CITY ORDINANCE NO, 776, SERIES OF 2025 OF THE CITY OF TALISAY, NEGROS OCCIDENTAL TRANSFERRING AND RELOCATING THE POBLACION PUBLIC MARKET IN BARANGAY ZONE 4-A TO BARANGAY ZONE 12-A, CITY OF TALISAY, NEGROS OCCIDENTAL, AS A VALID ENACTED ORDINANCE**

*WHEREAS*, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

*WHEREAS*, Ordinance No. 776, series of 2025 of the City of Talisay transferring and relocating the Poblacion Public Market in Barangay Zone 4-A to Barangay Zone 12-A, City of Talisay, Negros Occidental Ordinance No. 776, series of 2025 of the City of Talisay transferring and relocating the Poblacion Public Market in Barangay Zone 4-A to Barangay Zone 12-A, City of Talisay, Negros Occidental was submitted for review by the City of Talisay to the Sangguniang Panlalawigan of Negros Occidental;

*WHEREAS*, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the Subject Ordinance is within the conferred power of the Sangguniang Panlungsod of Talisay to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

Whereas, Republic Act No. 7160, otherwise known as "The Local Government Code of 1991, states under section 16 thereof that:

*"Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Xxx."*

**WHEREAS**, further, Section 458 of the same Code authorizes the Sangguniang Panlungsod to enact ordinances to ensure the efficient and effective delivery of basic services and facilities, including the regulation and maintenance of public markets and facilities;

**WHEREAS**, the transfer and relocation of the Poblacion Public Market from Barangay Zone 4-A to Barangay Zone 12-A, as embodied in Ordinance No. 776, series of 2025, is a policy determination of the City Government of Talisay in the exercise of its legislative discretion and administrative authority over local economic enterprises and public facilities. Such measure is consistent with the powers granted to cities under the Local Government Code to manage and regulate public markets and similar establishments within their territorial jurisdiction;

**WHEREAS**, Ordinance No. 776, series of 2025 of the City of Talisay, Negros Occidental may be given due course by the Honorable Sangguniang Panlalawigan, subject to compliance with the procedural requirements laid down under the Local Government Code of 1991;

**WHEREAS**, the ordinance complies with the six (6) generally accepted principles for a valid ordinance, as adopted by the Sangguniang Panlalawigan of Negros Occidental, which are:

- It must not contravene the Constitution or any statute.
- It must not be unfair or oppressive.
- It must not be partial or discriminatory.
- It must not prohibit but may regulate trade.
- It must be general and consistent with public policy.
- It must not be unreasonable.

**WHEREAS**, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;

**NOW THEREFORE**, premises considered, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr., unanimously seconded by all the members present during the regular session of the Sangguniang Panlalawigan of Negros Occidental, resolved, as it hereby resolves, to pass and approve this resolution to wit:
