RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2026-282 OF THE MUNICIPALITY OF CAUAYAN, NEGROS OCCIDENTAL, CREATING ADDITIONAL POSITIONS OF LOCAL LEGISLATIVE STAFF ASSISTANT III IN THE OFFICE OF THE SANGGUNIANG BAYAN, LOCAL REVENUE COLLECTION OFFICER III, REVENUE COLLECTION CLERK II AND ENGINEER I IN THE OFFICE OF THE MAYOR AND MEDICAL OFFICER III IN CAUAYAN DISTRICT HOSPITAL AND APPROPRIATING FUNDS FOR THE PURPOSE

WHEREAS, thereby presented to the Board for review and appropriate action is Municipal Ordinance No. 2026-282 of the City of Victorias, Negros Occidental, creating additional positions of Local Legislative Staff Assistant III in the Office of the Sangguniang Bayan, Local Revenue Collection Officer III, Revenue Collection Clerk II and Engineer I in the Office of the Mayor and Medical Officer III in Cauayan District Hospital and appropriating funds for the purpose;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject resolution reveals that the same is in accord with the provision as stated in Section 16 and 447(a)(1)(viii) under Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
