RESOLUTION APPROVING CITY ORDINANCE NO. 05-2026, SERIES OF 2026 OF THE CITY OF CADIZ, NEGROS OCCIDENTAL, ENTITLED: "AN ORDINANCE CREATING AND ABOLISHING THE FOLLOWING POSITIONS WITH CORRESPONDING ITEM NUMBERS UNDER THE 2026 PLANTILLA OF LGU PERSONNEL"

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is City Ordinance No. 05-2026, Series of 2026 of the City of Cadiz, Negros Occidental, entitled: ***"AN ORDINANCE CREATING AND ABOLISHING THE FOLLOWING POSITIONS WITH CORRESPONDING ITEM NUMBERS UNDER THE 2026 PLANTILLA OF LGU PERSONNEL"***;

WHEREAS, Section 76 of Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that every local government unit shall design and implement its own organizational structure and staffing pattern, taking into consideration its service requirements and subject to the approval of the Civil Service Commission;

WHEREAS, Section 458 (1) (viii) of the same Code grants the Sangguniang Panlungsod the authority to determine the positions and salaries, wages, allowances, and other emoluments and benefits of officials and employees paid wholly or mainly from city funds, and to provide for the creation and abolition of positions in accordance with law;

WHEREAS, the power to create and abolish positions is a legislative function lodged with the sanggunian, provided that such action is made in good faith, in the interest of public service, and subject to civil service laws, rules and regulations;

WHEREAS, in view of the foregoing, the SP Committee on Human Resource recommends approval of the same;

NOW, THEREFORE, on motion of Hon. Araceli T. Somosa and unanimously seconded by all the members present;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve City Ordinance No. 05-2026, Series of 2026 of the City of Cadiz, Negros Occidental, subject to the posting requirements under Section 59 of LGC 1991. Furthermore, the creation of positions/offices shall be subject to the following conditions, policies and reminders:

- a. All mandatory listed under RA 7160, otherwise known as the Local Government Code of 1991 have been created and provided for;
- b. The Salary Standardization Law (SSL) has been fully implemented;
- c. The general limitations on personal services expenditures are not exceeded;
- d. In cases of abolition of positions and the creation of new ones resulting from the abolition of existing positions in the career service, such abolition, or creation shall be made in accordance with Section 325(d) of RA 7160;
- e. The creation of new positions and salary increases or adjustments shall in no case be made retroactive per Section 325(g) of RA 7160;
- f. The creation of position shall have the corresponding budget, through an Appropriation Ordinance, to be considered valid; and
- g. Position Titles and Salary Grades shall conform to Local Budget Circular No. 137 dated July 13, 2021 of the Department of Budget and Management.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
